In return for the child being permitted to take part in the activities and to use the facilities and property of PEPPERDINE UNIVERSITY AND MALIBU BASEBALL CAMP LLC each of us makes the following promises and warrants the truth of the following facts:

1. I am familiar with the programs included in the activities and I understand officers, and employees of MALIBU BASEBALL CAMP LLC are available to discuss the activities if I should wish additional information. I also understand I am solely responsible for the arrival and departure of my child at the beginning and end of each day's program. I will not allow my child to remain on the premises of PEPPERDINE UNIVERSITY AND MALIBU BASEBALL CAMP LLC after each day's program without

appropriate supervision or the written permission of PEPPERDINE UNIVERSITY AND MALIBU BASEBALL CAMP LLC who will have no responsibility for the supervision of my child at times other than during the scheduled activities. I will inform my child that he/she is expected to cooperate with, and follow the directions of, the persons in charge of the activities and to act in a manner consistent with the spirit of good sportsmanship and respect for the rights of others.

2. My child is in good health, and I know of no reason why he/she would be incapable of participating in the activities. I will immediately notify the designated MALIBU BASEBALL CAMP LLC supervisor if change in my child's health or other condition would affect my child's ability to participate in the activities.

3. WAIVER OF LIABILITY: I waive and release any right I, my heirs, distributees, guardians, legal representatives and assigns may have or acquire to make a claim against, sue, attach the property of or prosecute PEPPERDINE UNIVERSITY AND MALIBU BASEBALL CAMP LLC or any of its members, directors, officers, agents, employees and affiliated organizations (herein referred to as .the releasees.) for monetary damages caused by injury to my child or damage to the property of my child or myself arising from my child's participation in the activities and use of the facilities and property of PEPPERDINE UNIVERSITY AND MALIBU BASEBALL CAMP LLC, whether or not the injury or damage results from the negligence or other action, except intentional acts, of any of the releasees.

ASSUMPTION OF RISK : I am aware that the sport of baseball may involve activities around equipment/play that may cause hazardous conditions which may include, among other things, dangerous zones within batting areas, and physical contact with other players, balls, and equipment. with knowledge of the dangers involved, I voluntarily ask that my child be allowed to take part in the activities. I ACCEPT ANY AND ALL RISKS TO MYSELF AND MY CHILD OF INJURY, DEATH AND PROPERTY DAMAGE ARISING FROM PARTICIPATION IN THE ACTIVITIES AND THE USE OF THE FACILITIES AND PROPERTY OF PEPPERDINE UNIVERSITY AND MALIBU BASEBALL CAMP LLC WHETHER OR NOT CAUSED BY THE NEGLIGENCE OR OTHER ACTION, EXCEPT INTENTIONAL ACTS, OF ANY OF THE RELEASEES.

### Malibu Baseball Technology Policy

Dear Parents,

Aside from the fact that cell phones are expensive and can get lost or stolen and that physical camp environment is not kind to such items, there is a fundamental problem with having cell phones at camp. Another drawback of having cell phones in camp is many of them have built-in cameras. Another concern is the use of devices that are capable of playing video. There have been cases around the country of campers bringing inappropriate downloaded images and video clips or movies on these devices to camps and sharing them with other campers. To lessen the possibility of this happening we have decided to ban all devices that are capable of showing video, movies or downloaded images. We believe that photographs help preserve those wonderful camp memories and encourage campers to bring cameras to camp, but would prefer them to be of the disposable or film variety. Like cell phones, digital cameras are expensive and could be lost or stolen and have the capability to upload digital images online. We reserve the right to view the images on any camera if we feel that there has been inappropriate behavior.

Please help us maintain a safe environment and explain this to your children. You should know that any camper that takes a compromising photograph of another camper or staff member and uploads it to the Internet or makes it public in any way may be subject to dismissal from camp or may not be allowed to return. If a law is broken, the appropriate authorities will be notified.

Profanity and tobacco are prohibited at Malibu Baseball Camp.

You can help by talking with your child before they leave for camp and telling them that if they are having a problem, with anything, please contact one of the adults immediately, whether it is their coach, the Head Counselor, the Director of camp or athletic trainer.
